1. Technical and Financial Bids:

The tender documents shall be submitted in two separate envelopes for technical and financial bids. **The technical bid should consist of all technical details with commercial terms and conditions along with Annexure-1, Annexure-II, Annexure-III, Annexure-IV, Annexure-V, Annexure-VI and Annexure-VII and the financial bid should consist of Annexure-VIII indicating the price for the quantity given in the table.**

The technical bid (containing Annexures I to VII with supporting documents) and the financial bid (containing Annexure-VIII) should be sealed in separate covers duly superscribed as “Technical Bid” and “Financial Bid”. Both these sealed covers containing Technical and Financial Bids should be put in a bigger envelope superscribed as “Bids for providing dual desk benches and top with recycled plastic sheets” and then sealed.

The financial bids of only those short-listed tenders after evaluation will be opened at the same time and venue on the same day or on the day as decided and communicated to the bidders.

2. Time and Place of Submission:

The tender documents shall be dropped in a Tender Box placed at, DRIIV Foundation, AD-256, 1st Floor, Main Building, Near Canara Bank, IIT Delhi, Hauz Khas, New Delhi – 110016 on or before 03:00 PM on 6th February, 2026 Documents received after the stipulated time and date will not be accepted under any circumstances. Either Tenderer himself/herself or a Single authorized representative will only be permitted to attend the technical bid and financial bid opening. No changes or additions or deletions to the submitted documents will be entertained. However, the Tender Opening and Evaluation Committee may seek clarification, if required.

Tender documents submitted through on-line will be rejected.

3. Bid Security/ Earnest Money Deposit (EMD):

The bid security (EMD) for Rs. 1,50,000/- shall be submitted in the form of Account payee draft or Bankers cheque drawn in favour of DRIIV Foundation and payable at New Delhi from any of the commercial banks, or through online as per the details given below under Bank Particulars, which should be valid for a minimum period of 45 days from date of opening of the technical bid. The Tenders without Earnest Money Deposit will be summarily rejected.

If the successful bidder withdraws/ modifies the bids during the period of validity, or fails to sign the contract or fails to submit the performance security before the deadline fixed for accepting the contract, the bid security (EMD) provided by the Tenderer shall be forfeited in full.

4. Performance Security:

The successful bidder shall furnish performance security for 5% of the contract value in the form of Account payee draft, Bankers cheque or online which should be valid for a minimum period of 60 days beyond the date of completion of all contractual obligations of the supplier including warranty obligation.

6. Warranty and Insurance:

The goods/items supplied should be of merchantable quality and shall have a warranty period of three years from the supply of the goods/items. The Tenderer's responsibility shall continue for a period of three years for their maintenance failing which their cost shall be recoverable even from the performance guarantee. **The benches shall also be insured for a period of three years (warranty period).**

7. Essential Requirements to be eligible for the bid:

- i. The Bidder shall have been in the business of manufacturing the dual desks/benches made of recyclable plastic atleast for a period of one year and supplied at least 500 benches made of recyclable plastic to the Government/Private Schools and Colleges. (A certificate issued by the local government agency/state/central governments and private schools containing the address and contact number be produced in respect of dual benches made with recyclable plastic. In case the bidder has supplied recyclable plastic benches to the schools as a manufacturer through the supplier, then the certificates issued by the schools/colleges to the concerned supplier be provided by the bidder along with the proof of issuing work order by that supplier to the bidder for providing benches made of recyclable plastic to the schools and colleges).

- ii. **The Manufacturer shall have a proven technology of at least two years to process/upcycle plastic waste, as approved under CPCB/SPCB guidelines.** (A relevant copy of the document may be attached).
- iii. **The manufacturer should produce a Greenguard Certificate.**
- iv. **The bidder shall also provide an undertaking given by the manufacturer that they will provide the plastic sheets made from recyclable plastic waste to the bidder for manufacturing the dual benches made of recyclable plastic sheets, on being awarded the present contract by DRIIV Foundation.**
- v. **The bidder shall provide service to the supplied benches during the period of warranty, failing which the requisite action shall be taken. (An undertaking be provided).**
- vi. **Technical presentation showcasing company profile like turnover, man power, team structure, methodology for implementing the project along with the tentative work plan, be provided.**
- vii. **All the required documents as given hereunder clause 8 along with the Bid submission.**

10. Place of Delivery and Delivery Schedule:

(i) Place of Delivery:

Place of Delivery shall be 35 Government Schools in NCR Region Delhi. The supply shall be made as per the specifications given in the letter of award. If the items supplied are found deficient in quality, the same will be summarily rejected and the Security Bid/ EMD and the Performance Security shall be forfeited.

Delay in supply will lead to penalty @1% of the value of the tender for every week of delay or part thereof, unless otherwise as decided by the competent authority.

11. Validity of bids:

The bids shall be valid for a period of ninety days from the date of opening of the tenders. This has to be clearly specified in the technical bid and the financial bid by the Tenderer.

12. Amendment and Extension of deadlines for submission of bids:

CEO, DRIIV Foundation reserves right to extend the deadlines for submission of the bids and amend any part of the tender document.

13. Right to withhold the tender process and cancellation of the supply order:

CEO, DRIIV Foundation also reserves the right to withhold or cancel the tender process without assigning any reasons thereof. CEO also reserves the right to cancel the supply order without stating any reasons. In case the supply order is cancelled due to breach of any of the terms and conditions specified in the tender document or for delay in implementing the schedule or due to non-performance or no progress etc., the performance guarantee shall stand forfeited.


